Responsive to continuing economic challenges,

Board holds tax levy increase at 2.44%

As a center of excellence, the educational focus of the Olean City School District is preparing students for their future and ours. We offer rigorous curriculum, hold high standards for all students and staff, and provide a wide variety of classes to meet the varied interest of the learners. Maintaining these virtues while preserving programs was, and will continue to be, the major focus during budget development.

For the 2010-11 school year, the Board of Education set the goal of less then a 3% increase in the tax levy. Given the parameters set by the Board of Education, the reduction in State Aid, and the knowledge that the stimulus money is not being renewed; the budget development process became one of creating a budget that balanced program offerings and securing staffing to ensure the District's ability to maintain quality programming for our learners. The areas of reduction were chosen by closely examining class size; mandated versus non mandated programs; grant supported programs versus locally funded programs; and reductions through attrition due to retirements.

We reached the goal put forth to us by the Board of Education of under 3% increase to the tax levy; we are at 2.44%. In doing so we are forced to reduce staff while also reducing some areas of programming. The 2010-11 budget reflects a reduction of 12 professional staff as follows: Physical Education, Counseling, Library, Music, Elementary Classroom Teachers along with Middle School and High School Teachers, (Foreign Language, Social Studies, English, Business) and the position of Director of Curriculum. Other reductions made were in the areas of BOCES services, Modified Sports, Co-curricular activities, materials, supplies, equipment, utilities, field trips, conferences, and other contractual expenses.

The 2010-11 budget was developed with the 2011-12 school year in mind. We are being warned that the worst is yet to come. Even with reductions this year, the impact of less State Aid on



the budget for next year will be more challenging. The economic situation across the Nation is bleak and we must be responsive to the realities of our situation both nationally and locally.

I want to extend my sincere appreciation to our students, our parents, the Board of Education and our community members for all of the support and direction that has guided our decision making process.

A special THANK YOU is extended to our outstanding employees who have done everything possible to help reduce daily operating expenses by being more attuned to going "green" and for maintaining a standard of excellence during this very difficult economic downturn. You demonstrate your commitment to the students, to one another and to the community each and every day. It is an honor and a privilege to work along side each and every one of you!





Explanation of Three Part Budget Presentation

- Chapter 436 of the Laws of 1997 require public school boards of education to present the proposed budget in three parts. As a result, this presentation is organized around the following components; administrative, capital, and program:

Administrative Component: Includes expenses associated with the operation of the school board, superintendent's office, and business office. Includes salaries and benefits for all certified administrators and supervisors who spend a major-

ity of their time performing administrative duties, consulting costs not directly related to instructional programs, and all other activities that are administrative in nature.

Capital Component: Includes debt service for all facilities financed by bonds and notes of the district, lease expenditures, costs resulting from judgments in tax certiorari proceedings, awards from court judgments, administrative orders and settled claims, cost of construction, acquisition, reconstruction, rehabilitation, and improvements of school buildings,

all expenses associated with custodial and maintenance salaries and benefits, service contracts, supplies, utilities, maintenance, and repair of school facilities

Program Component: Includes salaries/benefits of teachers and any school administrator or supervisor who spend a majority of their time performing teaching duties, and all transportation operating expenses.



The New York State School Report Card

Fiscal Accountability Supplement for Olean City School District

New York State Education Law and the Commissioner's Regulations require the attachment of the NYS School Report Card to the public school district budget proposal. The regulations require that certain expenditure ratios for general education and special education students be reported and compared with ratios for similar districts and all public schools in New York State. The required ratios for this district are reported below.

Instructional Expenditures for General Education are K-12 expenditures for classroom instruction (excluding Special Education) plus a proration of building level administrative and instructional support expenditures. These expenditures include amounts for instruction of students with disabilities in a general education setting. District expenditures, such as transportation, debt service, and district-wide administration, are not included.

The pupil count for General Education is K-12 average daily membership plus K-12 pupils for whom the district pays tuition to another school district. This number represents all pupils, including those classified as having disabilities and those not classified, excluding only students with disabilities placed out of district. For districts in which a county jail is located, this number includes incarcerated youth to whom the district must provide an education program.

Instructional Expenditures for Special Education are K-12 expenditures for students with disabilities (including summer special education expenditures) plus a proration of building-level administrative and instructional support expenditures. District expenditures, such as transportation, debt service, and district-wide administration, are not included.

The pupil count for Special Education is a count of K-12 students with disabilities as of December 1, 2007 plus students for whom the district receives tuition from another district plus students for whom the district pays tuition to another district. Students attending the State schools at Rome and Batavia, private placements, and out-of-state placements are included.

Instructional Expenditures Per Pupil is the simple arithmetic ratio of Instructional Expenditures to Pupils. The total cost of instruction for students with disabilities may include both general and special education expenditures. Special education services provided in the general education classroom may benefit students not classified as having disabilities.


